#### Overview:

MERS® Link allows you to search for loans to view loan information, including servicer, property preservation company, and recording information. Search keys include MIN, Social Security Number, FHA/VA/MI Certificate Number, Borrower Name, Corporation Name, and Property Address. 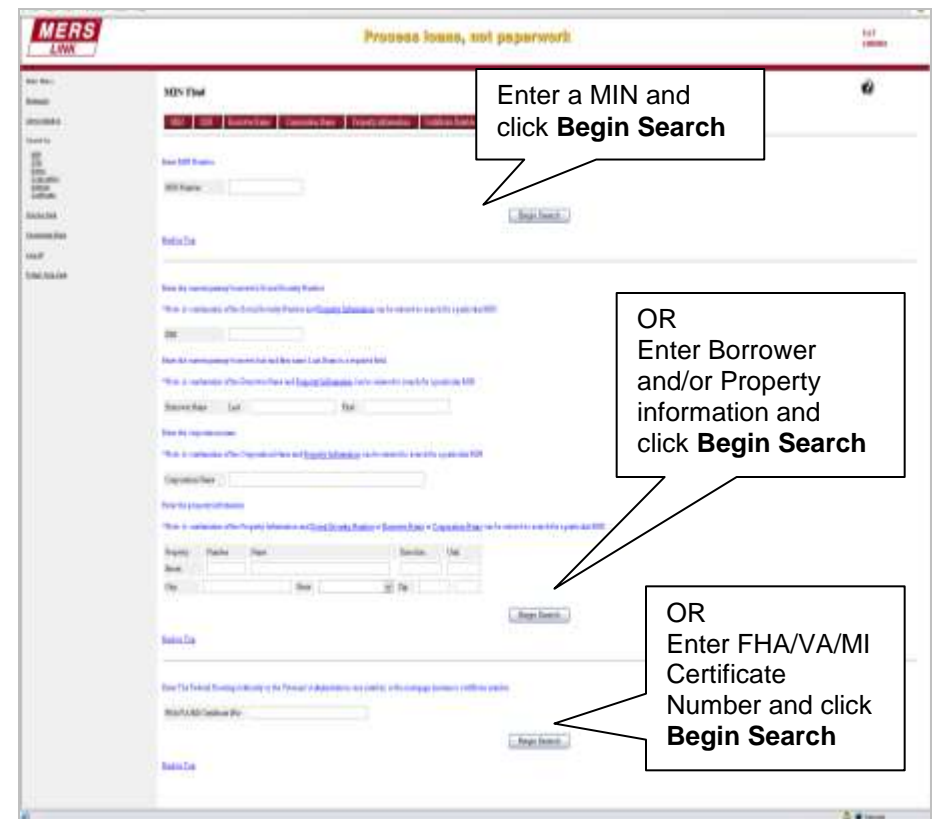
#### Wildcards

The ampersand (&) is a valid wildcard for numeric fields and the asterisk (\*) is a valid wildcard for alphabetical fields.

#### Archived MINs

The Borrower First Name and Certificate Number fields are not archived. If you search by Borrower Name, archived MINs will be retrieved if they match the Last Name entered, ignoring any First Name entered. Archived MINs cannot be retrieved using Certificate Number. MINs are archived 16-84 months after they are deactivated (e.g. MINs in Foreclosure Complete, Paid in Full or Registration Reversal status).
